### Be an Election Judge

The Lake County Clerk is the Chief Election Authority for the County. Election judges are responsible for the proper and lawful conduct of the election in the polling place. Election judges are commissioned as offices of the Circuit Court and are required to take an oath to uphold the Constitutions of the United States and the State of Illinois in performing their duties. Election judges help ensure that every person qualified to vote is permitted to vote and that every person permitted to vote is qualified to vote.

November 5, 2016	Last day for early voting at township office
November 8, 2016	GENERAL ELECTION - Polls open from 6:00 a.m. until 7:00 p.m.

#### ARE YOU REGISTERED TO VOTE?

You may register to vote at:

Or at any facility that has a registrar on duty, (for example; libraries, village halls, county offices)

Voter Registration at Vernon Township closes October 11, 2016.

#### WHO CAN REGISTER TO VOTE?

You may register to vote if you are:

- A United States citizen
- 18 years of age by the date of the next election
- A resident of your Lake County precinct address for 30 days immediately prior to an election.

Two forms of identification are required to register through a deputy registrar. At least one of the two forms must show your name and current address. Only one form of identification may be a piece of mail for a contractual service addressed and delivered to you

#### DOES MY VOTER REGISTRATION EXPIRE?

Your voter registration does not expire unless you move or change your name.

Change of name - Should you change your name by marriage, divorce or other legal name change, you must re-register under your new name and provide the new signature on your registration record.

Change of address - If you move within Lake County, you must provide written notification of your new address and sign the request.

Mail notification including your name, old and new address, date of birth and your signature or complete the back of your voter I.D. card including your signature. Both of these should be mailed to the County Clerk's Office.

#### **VOTER PROGRAMS**

Voting By Mail - You can request a one-time ballot or a Permanent Application for a Ballot by mail by visiting Voter Power and clicking the "Application to Vote by Mail" button. For more information, contact the Voting by Mail department by e-mail at VotingByMail@lakecountyil.gov or call (847) 377-2406.

Snowbird Program-This program is intended to simplify voting for registered voters who temporarily vacation or visit outside their precinct each year. Those enrolled will automatically receive an application for ballot by mail as specified. Use the enrollment form which can be printed, signed and mailed to the County. (Form is available at Vernon Township or on line at www. lakecountyil.gov)

Student Program- The Temporarily Absent Student Program is available to students away at school. This program simplifies voting for students who wish to receive an application for ballot at their school address prior to each election. A student must be a registered voter in order to enroll in this program. (Form is available at Vernon Township or on line at www.lakecountyil.gov)

#### POLLING PLACE LOCATIONS

Your polling place is determined by your precinct number and is listed on your Certificate of Voter Registration card. If you need further information on your polling place you can either call the Lake County Clerk's office at (847) 377-2314 or visit their website at www.lakecountyil.gov .

### From the Desk of the Assessor

### Making an Assessment Appeal

All property owners may appeal their assessed value on their property. An appeal is NOT a disagreement of property taxes; it is an attempt to prove an unfair market value of your property.

Before you make an appeal, you should check the county's web site to verify the amenities that you are being assessed for, such as the number of bathrooms, basement, patio, deck, fireplace, etc. This can be done by going to www.lakecountyil.gov. If there is a factual error, it can be corrected in the Assessor's Office and no appeal at the county level is necessary.

If you feel that you have a case, you need to gather as much information as you can to prove why the property is not assessed correctly. The Lake County Board of Review hears testimony on written appeals of any real estate that claims to be over-assessed. You can download an appeal form and rules at the Board of Reviews home page at http://lakecountyil.gov/assessor/boardofreview, or file online as well. All appeals must be filed with the Board of Review before 30 calendar days after date of publication of the assessment changes for the township.

To look at other assessments in your area, you can visit the Lake County's web page www.lakecountyil.gov.

The Township Assessor's Office does NOT determine the amount of your tax bill; we are here to determine the value of your property

### **Senior Exemptions**

All too often we have seniors, 65 years of age or older come into our office saying they did not know there was such a thing as a Senior Exemption. Once you turn 65 years of age you are eligible for an additional exemption on your property taxes. The senior exemption takes an additional \$5,000 off of your assessment before the tax rate is applied. If your tax rate is 9% it could save you \$450.00. If you're missing out on this exemption come into our office to start the paper work, please be aware if your property is in trust you need to bring your trust in as well.

If you are a senior with income of \$55,000 or below adjusted gross income after adding in total social security benefits you may be eligible for an additional senior exemption called Senior Freeze Exemption. If you have any questions about exemptions, give our office a call at (847) 634-4602.

## **Highway Department Briefs**

### Vernon Township Transfers \$425,000 to Local Villages

Vernon Township Highway Department transfers approximately \$425,000 of the general road fund tax money to the villages within Vernon Township. The tax extension for the general road fund was \$898,435. The County uses the assessed value of the properties within each village (minus the unincorporated areas) to calculate how much of the tax money will be distributed to that village.

Listed to the right are the monies some villages will receive from the tax this year.

### **Electronic Recycling**

On April 16, 2016, Vernon Township, the Village of Vernon Hills and other sponsors participated in an electronic recycling and shredding event. Approximately 1,000 cars came through on the day of the event dropping off over 82,000 pounds of electronics filling 4 semi-trucks.

### **Adult Passport Renewals**

Adult Passport renewals are simple and easy to do. To renew an adult passport, visit <u>www.travel.state.gov</u> and download form DS-82 along with the instructions.

You can renew by mail if all of the following are true of your most recent U.S. Passport:

- It is undamaged and can be submitted with your application;
- Was issued when you were age 16 or older;
- Was issued within the last 15 years; (not expired more than 5 years) and
- Was issued in your current name or you can legally document your name change with a certified copy of your marriage certificate or government-issued document evidencing your legal name change.

Complete the application and mail the application, payment and the passport to the address on the form. **A trip to an acceptance facility is not necessary!** Adult renewals are done by the adult and acceptance agencies do not accept these applications.

Anyone applying for a first time passport must apply in person using form DS-11. Minors and young adults with a currently expired or expiring 5 year passport must also apply in person using the DS-11 form.

### **Passport Acceptance**

Vernon Township accepts passport applications, (form DS 11), Monday-Friday from 9:00 a.m. until 3:00 p.m. No appointment is necessary; however peak times are during lunch hours. Payment for the passport must be made by personal check or money order. Vernon Township does not accept credit cards. The township will accept cash/check for the agent fee.

Prior to arriving at the township it would be very beneficial for you to check the Department of State's website at www.travel.state.gov. The web site allows you to download appropriate applications, informs you of the documentation you will need to process an application, and estimates current processing times. Please note that if you fill out the application by hand, use black ink only. Forms completed in other color ink will have to be re-written. In addition, applications have to be printed on two separate sheets of paper not double sided on one piece of paper.

### Stevenson Parking Permits

Parking permits are available for Stevenson Students to park at the Prairie View Metra Station.

Parking permits allow students to park in the east lot of the train station. Instead of paying the daily fee of \$1.50 at the pay station,

students with permits would be able to park their vehicles and immediately leave for school. Permit applications are available at the township office or on our web site www. vernontownship.com. Shown on the right are the fees for the 2016-2017 Stevenson parking permits.
