#### **VOTING BY MAIL**

Illinois law permits any registered voter to receive a ballot by mail. Voters may use the online form to make a one-time or permanent request for a ballot.

#### **Snowbird**

Voters who travel seasonally can enroll in the Snowbird Program and specify elections and an alternate address to which a ballot should be mailed.

#### Student Program

Temporarily Absent Student Program is available to students away at school. A student must be a registered voter in order to enroll in the program.

#### **Voter Registration**

Please make sure you are registered at your current address. Voter registration closes 27 days before the election. You may register to vote at Vernon Township Monday thru Friday from 8:30 a.m.- 4:30 p.m.

# 2015 - Fishing and Hunting License

New this year: Over age 75 fees - The fee for all sport fishing licenses and hunting licenses shall be \$1 for residents over 75 years old. Additionally, the fees for Salmon Stamps, Inland Trout Stamps, State Migratory Waterfowl Stamps and State Habitat Stamps shall be waived for residents over 75 years old.

# Highway Department Briefs

#### Spring Clean Up Weekend

Spring Clean Up Weekend in unincorporated Vernon Township will take place on May  $2^{nd}$  and  $3^{rd}$ , with a rain date of May  $9^{th}$  and  $10^{th}$ . If you do not live in an unincorporated area, please call your local village to inquire about such programs in your area.

Dumpsters will be located in the unincorporated areas of: Horatio Gardens, Krisview Acres, The Meadows, Pekara, Elm Road, Woodbine Circle and Juneway.

When discarding items into the dumpsters, please take the time to do so in such a way that will allow for the maximum use of the space provided. Please refrain from filling the dumpsters over the top.

Unfortunately there are some items that cannot be disposed of into the dumpsters, and they are:

- Electronics / Appliances
- Tires
- Paint, solvents, household chemicals or hazardous materials
- Yard waste (grass clippings, brush or tree limbs)
- Construction debris

#### De-Icing Program

Vernon Township Highway Department began using a de-icing solution in 2008. De-icing is a combination of organic materials and existing snow removal products.

Geomelt is a 100% organic accelerator that enhances any and all chlorides and salt brine that it is used with a combination of Geomelt, liquid salt brine and calcium chloride is sprayed onto the rock salt before it is applied to the road.

The benefits of this solution are that it will work to 25 degrees below zero. The solution is less corrosive on Township trucks, the roads, and road infrastructure such as storm sewers and to personal vehicles. Additionally, it reduces the green space damage along the roadsides. The Geomelt anti-bonding solution continues to protect the roads after application by holding the salt, salt brine and calcium chloride on the roads. Because of this, the amount of hard packed snow on the road is lessened by an estimated 95%.

In 2008 Vernon Township Highway Department was one of the first municipalities to use the Geomelt mix solution. Throughout the past 7 years of using this product, the highway department has fine-tuned the mixture to gain maximum performance. Also, the highway department has trained several neighboring municipalities on the blending and use of Geomelt.

# Save the Rain For A Sunny Day

A rain barrel connected to your downspout is a great way to keep storm water out of the system and to cut down on your water bill. Because you are collecting right off the roof, it has few contaminants and is perfect for watering the garden. Diverting water from your downspout into a rainwater catchment system has several advantages:

- Reduces the volume of water flowing to the sewer treatment facility
- Backup source of water during times of drought or between rain showers
- Helps to keep our creeks and beaches clean
- Saves money lowering your water bill; naturally softened water is great for delicate houseplants, auto cleaning and window washing
- Reduces the need for additional tax dollars earmarked for sewer expansion
- Chlorine-free water helps maintain a healthy biotic community in the soil

# From the Desk of the Assessor

#### 2013 TAX BILL PAID IN 2014

Homeowners requiring a copy of their tax bills for income tax purposes may obtain them from the Lake County's Treasurer's website at: http://lakecountyil.gov/TREASURER.You will need your PIN, also known as a property index number; however, if you do not have it your address will work as well. If you have further questions about your tax bill you can also call the Treasurer at (847) 377-2323.

#### **Deed Information**

When you purchased your property an unrecorded copy of your deed was given to you or your attorney at the time of closing. Once it is officially recorded at the county level, they then send out the certified copy within the next few weeks. We sometimes hear from homeowners that they think because they still have a mortgage on their home that they don't have their deed. This is not true; the mortgage company will place a lien on your property until the mortgage is paid off. Once the mortgage is paid off the mortgage company prepares a release deed clearing you from the lien. You can request another copy of your original deed yourself if you can't find it. The Lake County Recorder of Deed's office will send out another copy for a minimal cost. Do not be fooled by a random letter sent from a third party stating that they can get you your deed for a pretty steep price. To request a copy of your deed contact the Lake County Recorder of Deeds at (847) 377-2678.

#### Exemptions

If you are 65 years or older you can apply for a Senior Citizen's Exemption. Our office has applications available for you to fill out or you can go online and get one. If you prefer to go online, visit www.lakecountyil.gov, once you are there on the top right hand corner is a white search box, just type in "senior citizen exemption". If you choose to fill out the form from the online application you will need to attach a copy of your deed and driver's license as proof of age to it. If your property is in a trust, you must supply the article of the trust showing Lifetime Provisions indicating that you are the beneficiary of the proceeds if your home were to be sold. An example of that would read: During My Lifetime all income will be distributed etc., or I retain the right to control and distribute income from my trust etc. The application can then be mailed directly to the county at: Chief County Assessment Office 18 N. County St. Waukegan, Illinois 60085, or it can be brought to our office to be mailed. If you have any questions about filling out the application, your deed or your trust you can call our office for further instructions. We can also e-mail you an application packet if you would prefer that as well. We can be reached at the assessor's office (847) 634-4602

#### Quadrennial Assessments

This year, 2015 is our Quadrennial assessment year. This means that the Illinois statutes require assessors in all counties to revalue ALL properties in their jurisdiction. New 2015 assessment notices will be sent out in the month of August. Assessments are based on the prior three years of sales, so what will be looked at are sales from 2014, 2013 and 2012.

# Clarke Mosquito Abatement

As the weather gets warmer the emergence of mosquitoes begins. To help eliminate this continued threat, Vernon Township has again contracted with Clarke Mosquito Control to treat unincorporated Vernon Township. For further information regarding this program or if you are having problems with mosquitoes near your home please call the Mosquito hot line at (800) 942-2555. If you do not live in an unincorporated area, please contact the village you live in regarding their abatement program.

# **AARP Driver Safety Program**

The AARP Driver Safety Program is an eight hour program designed to help you understand the effects of aging on your driving and learn driving strategies that take into account the changes we experience as we age. Completion of this program may entitle you to receive discounts on your auto insurance. Attendance on both days is required to receive a certificate that may reduce your auto premiums. # **Passport Reminders**

The summer travel season will soon be upon us! Be sure to check the Department of State's updated web site, www.travel.state.gov for the most current passport information.

The State Department has revised their website to make it more user friendly. On the site you will find entry requirements by country, information on requirements for new passports, renewing passports, obtaining passports for children under 16, obtaining passports for children 16 and older as well as answers to some of the most common travel questions.

The Township accepts passport applications Monday through Friday between the hours of 9 a.m. to 3 p.m. No appointment is necessary. Applications are available at the Township or may be downloaded from the Department of State's website above. The Department of State is in the process of revising some forms. Check on www.travel.state.gov for the most current applications. It may be necessary to rewrite a form at the Township office should an older form be presented.

When completing a passport application use only black ink and do not cross off items or use white out. The passport agent may require a new application be written if completed in another ink color and/or not legible. Every passport application must have the social security number on it. Anyone applying for a passport must be present at the time the application is accepted, this includes children. Please be aware that Vernon Township does not accept debit/credit cards; payment to the Department of State must be a personal check or money order. The Township will accept cash for the agent fee and photo. The Township takes passport photos for \$8.00

#### **Pool Pass Information**

Any person wishing to enjoy the Vernon Township Aquatic Center must have a valid season pass or purchase a daily pass at the pool registration desk. To be eligible for resident rates, you must provide proof of your Vernon Township residency with a valid driver's license or by a current real estate tax bill. Only those immediate family members and care givers living at your residence will be eligible for family rates. (See guidelines.)

All season pass holders are required to have a photo identification card, issued by Vernon Township. If you cannot present this card to the pool attendant at the time of check-in, you will be charged the daily user rate.

Through the season, pool pass photos are taken at the Vernon Township Administrative Center, Monday - Friday, 8:30 a.m. - 4:30 p.m. For your convenience, additional pool pass photo hours are as follows:

> April 28, 2015 to May 16, 2015 (Tentative) Tuesdays and Thursdays - 8:30 a.m. - 7:00 p.m. Saturdays 9:00 a.m. - Noon.

Individuals must be present for their pass photo. We will not take a picture of a photo brought in by another person. Vernon Township will NOT give credit towards the purchase of a pool pass for any daily fees

#### Pass Guidelines

- · Admission to the pool requires payment of a daily admission fee or a pool pass, regardless of age.
- A pool pass must be presented upon check-in at the pool. If you can not present the card at the time of check-in, you will be charged the daily user rate. No other form of identification will be accepted for admission into the pool.
- · Pool passes are NOT transferable and not refundable.
- · Only immediate family members living in your residence are eligible for family rates. Nannies and live-in baby sitters can be included, but must provide proof of residency at your address. (Drivers license or State of Illinois ID ONLY.) Live out nannies and baby sitters must purchase an individual pass or purchase a daily pass.
- · Passes used fraudulently or false information on the registration form may result in all passes being revoked with no refund.
- A responsible adult over the age of 16 must accompany children ages 8 and below.
- Replacement passes are \$5.00

The above is only a partial list of pool guidelines. Vernon Township has the authority to enforce additional guidelines.
