SHIP representatives are not affiliated with any insurance company.

Vernon Township is a host site for the Illinois Department on Aging's Senior Health Insurance Program. Trained volunteers are here the third Monday and Tuesday of each month from 9:00 a.m. to 12 Noon.

SHIP is a national program that provides FREE counseling and information on Enrollment, Prescription Drug Plans-(Please bring a list of all your medications and the doses), Supplemental Plans, Subsidies to offset the cost of Medicare and Claims and Appeals.

## **Vernon Township Cemeteries**

The Vernon Township Cemetery is located in Lincolnshire at the corner of Old Half Day Rd. and Milwaukee Ave. (behind strip mall). Grave sites, mausoleum crypts and niches are available for purchase. The mausoleum contains 64 crypts, and 24 columbarium niches. Two additional columbarium units were recently added to the cemetery. Each individual crypt or niche can be personalized with your inscriptions.

Vernon Township is selling the crypts for \$5,000 and the niche for \$700. The individual grave sites are \$800.00.



The Diamond Lake Cemetery is located on Route 60 (east of Route 45) in Mundelein, IL. Grave sites are available at the cost of \$800.00

# Vernon Township Vehicle Stickers

Vernon Township will have the 2015-2016 vehicle stickers available at the Vernon Township offices beginning in December 2014. Although these stickers are not mandatory, they are available for the convenience of our residents. To obtain a free vehicle sticker you must:

- Be a Vernon Township Resident
- Bring in a current vehicle registration for each vehicle; vehicles must be registered at a Vernon Township address

## Medical Lending Closet

Vernon Township's Medical Lending Closet has a variety of free medical equipment for temporary use by our residents. Wheelchairs are available for a \$50 refundable deposit.

Please call the township at (847) 634-4600 ahead of picking up equipment to be sure the equipment needed is available. When picking up the equipment you will be asked to fill out a small application and show proof of residency.

The closet is open Monday-Friday from 8:30 a.m. until 4:00 p.m. for Vernon Township residents only, with the exception of Cook County Buffalo Grove. We accept donations of medical equipment during the same hours.

## Benefit Access Program - BAP

The Benefit Access Program is a State program designed for low income Senior Citizens (Household income less than \$27,610 for a single person or \$36,635 for two) or Persons with disabilities (age 16 - 64 and totally disabled). This programs offers license plate renewal discount and Seniors Ride Free Transit Benefit or Persons with disabilities Ride Free Transit Benefits. Applying for this program must be done online on the Illinois Department on Aging website, (www.state.il.us/aging) and click on the Benefit Access Application button on the right hand of the screen. Applications can only be filed on the internet. For residents of the township unable to use the internet and/or needing assistance applying for this program, appointments can be made by calling (847) 634-1542.

## **Snow Removal Procedures**

After a minimum 2" snowfall, parking is not permitted on Township maintained roads, until it has been cleared edge to edge. Parked vehicles may be towed with the owner responsible for related costs.


## A Reminder When Shoveling Snow

When shoveling your driveway of snow, the best way to assure that the snow plows clearing the street will minimize the amount of snow left in an already cleared driveway is to shovel snow in the direction of traffic and also make a pocket on the opposite side of your driveway. (See illustration to the right.)

By doing this, snow that has accumulated on the plow will dump into that pocket, and will reduce the possibility of snowplows inadvertently making your driveway snowbound.

## **Clearing Driveway Snow Sensibly**

When removing snow from your driveway, do not shove, push or blow it onto the public roadway, as this will create a slippery and hazardous surface when



When piling snow at your driveway entrance, make low mounds on both sides. Make them low enough so the roadway is clearly visible in both directions when you are seated in your vehicle. Also, please prevent your children from playing on or digging tunnels in the snow piles as the snowplow drivers may not be able to see the children at play.

## Don't Forget Your Mail Carrier

Clear an area in front of your mailbox so they can easily approach. If there is a fire hydrant on your property, shovel a path to and around it from the roadway.

## Vehicle Damage

To prevent damage to vehicles and snow plows please remove all decorative rocks, logs or other objects and place at least 6 feet from the paved edge of the road.

## Storm Sewer Project


Over the summer the Vernon Township Highway Department crew installed an extensive storm sewer system. The system was installed to minimize multiple areas of standing water and increase the flow of storm water off the properties on North Elm Road and Oak Lane in unincoporated Vernon Township.

## **Year Round Electronics Collection**

Vernon Township Highway Department continues with its year round electronic recycling program. A dumpster is located on the west side of the township offices for electronics to be dropped off and properly recycled. Since this program started three years ago, over 537,000 pounds of recycled materials have been collected. This is an unmanned program so if you require help to remove the items from your vehicle, please call ahead and make an appointment. (847)634-4600. The hours for drop off are Monday through Friday from 8:00 a.m. until 3:00 p.m.

**Items Accepted:** Personal Computers, Monitors, Computer Drives, Keyboards, Modems, Mainframes, Scanners, Printers, PDA Organizers, Cellular Phones, Televisions, Stereos, MP3 Players, CD Players, DVD Players, VCR's, Cameras, Video Games, Fax Machines, Shredders, Adding Machines, Batteries, Cd's, DVD's, Tapes, and Small Household Appliances.

**Items NOT Accepted:** Broken Glass, Air Conditioners, Liquid or Chemical Waste, Electric Fixtures, Fluorescent Light Bulbs, Dehumidifiers, Packaging Materials, Large Household Appliances.



# The Assessor's Report

## **Senior Citizens Homestead Exemption**

If you are the owner of a residential property and are 65 years or older, you qualify for a Senior Homestead Exemption. The Senior Homestead Exemption lowers your equalized assessed value by \$5,000. We do not know when homeowners turn 65, it is essential for you to call our office to get this exemption started. If your property is in a trust we will need you to bring in your trust as well.

## Homestead Limited Exemption

Also known as General Homestead Exemption, this exemption lowers your equalized assessed value of your property by \$6,000. This exemption is given to all properties as long as it's your primary residence and you are not receiving a Homestead Exemption at any other property. Rental properties do NOT qualify for a Homestead Limited Exemption. It is the responsibility of each taxpayer to confirm that the Homestead Limited Exemption has been applied to their tax bill.

## Chief County Assessment Office Exemption Recapture Information

New state law (effective June 1, 2014) gives the Chief County Assessment Office authority to recapture taxable value in instances where property owners have received homestead benefits erroneously. The new law aims to create a more fairly distributed property tax burden which benefits taxpayers. Lake County is providing an amnesty period for the remaining months of 2014 in order to gain maximum compliance.

Taxpayers are eligible to receive homestead exemptions on only one property in any given year. This applies to properties outside of Lake County and even in other states. You may check your property exemption status, or report any erroneous exemptions by contacting your local township assessor's office, or the Chief County Assessment Office. Taxpayers will be notified with a letter if their homestead exemptions are being removed. The removal decision can be appealed to the Chief County Assessment Officer, and if needed to the Lake County Board of Review.

The Chief County Assessment Office has a web page dedicated entirely to homestead exemption recapture/fraud information at assessor. lakecountyil.gov. An anonymous homestead exemption tip line has been set up for taxpayer reporting on homestead exemption issues. The phone number is (847) 377-4799. The e-mail box for reporting erroneous exemptions/fraud is Exemptions@lakecountyil.gov. When contacting our office, please make sure to tell us the property index number and/or property address and why the exemption should be removed.

## **Passport Acceptance**

Vernon Township accepts passport applications Monday-Friday from 9:00 a.m. until 3:00 p.m. No appointment is necessary; however peak times are during lunch hours. We have passport photo service on site for the fee of \$8.00 per set of photos. Payment for the passport must be made by personal check or money order. VernonTownship does not accept credit cards. The township will accept cash/check for the agent fee and photo.

Prior to arriving at the township it would be very beneficial for you to check the Department of State's website at www.travel.state.gov. The web site allows you to download appropriate applications, informs you of the documentation you will need to process an application, and estimates current processing times. Please note that if you fill out the application by hand, use black ink only. Forms completed in other color ink will have to be re-written. In addition, applications have to be **printed on two separate sheets of paper not double** sided on one piece of paper.

## Prairie View Train Station Overnight Parking

Overnight parking is available at the Prairie View Metra Station. Designated overnight parking spaces are number 117 through 124. Persons needing to leave their vehicle over night at the train station should contact Vernon Township at (847) 634-4600. The make and model of the vehicle, license number and parking space is needed to leave your vehicle overnight. Parking in the designated overnight spaces will assist our snow plow drivers in removing the snow safely for all commuters. In the event that spaces 117 through 124 are not available, please park in the west lot, close to Route 22 (Half Day Road) and contact the township with your parking information.

## Stevenson High School Student Parking

Stevenson student parking at the Prairie View Train Station is by special arrangements with Metra and Vernon Township. Stevenson students are required to park in the east side parking lot. The west lot is for commuters only. Students are required to purchase a permit to park at the east Prairie View Station lot. Daily parking is not allowed. Use of the west side parking lot without a permit or failure to display the parking permit may result in ticketing and fees.

## Important: Please Read Before Camp Registration

- 1. Each camper requires his or her own registration form.
- 2. Do not mail in your camper's registration form.
- 3. Proof of age (birth certificate) is required at registration, for each new camper, including siblings of returning campers.
- 4. Proof of residency is required. If a parent does not have a valid drivers license to meet this requirement, please contact the township prior to registration to determine what other information can be used.
- 5. All camps require a \$50 nonrefundable, nontransferable deposit at the time of registration, unless otherwise noted in the registration procedures. <u>Cash deposits will not be accepted.</u>
- 6. Camp registration will not proceed if items 3,4 and 5 listed above are not satisfied.
- 7. The fee balance is due on or before March 20, 2015. If the balance is not paid by that date, the camper's place will be given to a camper on the waiting list. No bill or reminder will be sent to you by Vernon Township. If you require a payment plan, you must contact the Township after January 8, 2015, but before January 30, 2015. You may pay the entire balance at the time of registration.
- 8. <u>After March 20, 2015, refunds will only be granted for medical reasons or if a replacement camper can be found by Vernon Township.</u> You must submit a letter from your doctor on his/her letterhead in order to receive this refund.
