## Answers to your Medicare Questions

Are you thinking of retiring in 2016? Are you completely confused about your Medicare options? If you answered "yes" to either of these questions, call Vernon Township at (847) 634-4600 to make a one-on-one appointment with a Senior Health Insurance Program (SHIP) Representative. Vernon Township is a host site for the Illinois Department on Aging's Senior Health Insurance Program. Trained volunteers are here to help answer all your questions.

SHIP is a national program that provides FREE counseling and information on the following Medicare programs:

- Enrollment
- Prescription Drug Plans-(Please bring a list of all your medications and the doses)
- Supplemental Plans
- Subsidies to offset the cost of Medicare
- Claims and Appeals

It is highly recommended that during open enrollment, October 15, 2015 through December 7, 2015, anyone who is currently on a prescription drug program should review the programs available for the following year. Drug coverage changes on a yearly basis so programs should be reviewed each year.

## Passport Acceptance

Vernon Township accepts passport applications Monday-Friday from 9:00 a.m. until 3:00 p.m. No appointment is necessary; however peak times are during lunch hours. We have passport photo service on site for the fee of \$8.00 per set of photos. Payment for the passport must be made by personal check or money order. Vernon Township does not accept credit cards. The township will accept cash/check for the agent fee and photo.

Prior to arriving at the township it would be very beneficial for you to check the Department of State's website at www.travel.state.gov. The web site allows you to download appropriate applications, informs you of the documentation you will need to process an application, and estimates current processing times. Please note that if you fill out the application by hand, use black ink only. Forms completed in other color ink will have to be re-written. In addition, applications have to be **printed on two** separate sheets of paper not double sided on one piece of paper.

## Vernon Township Cemeteries

The Vernon Township Cemetery is located in Lincolnshire at the corner of Old Half Day Road and Milwaukee Avenue. Grave sites and mausoleum spaces are available for purchase. The mausoleum contains 64 crypts, and 24 columbarium niches. Two additional columbarium units were recently added to the cemetery. Each individual crypt or niche may be personalized.

The Diamond Lake Cemetery is located on Route 60 (east of Route 45) in Mundelein. Only grave sites are available at this cemetery.

Prices for both cemeteries are as follows:

- Grave Sites \$900.00
- Opening and Closing Costs \$900.00
- Crypts \$5,000.00
- Niches \$800.00

#### Voter Registration

Voter registration allows qualified voters to participate in the electoral process and exercise one of their most basic rights.

To register to vote you must:

- Be a United States citizen
- Be at least 18 years of age on or before the next election (17 year olds may register and vote in even-year primaries if 18th birthday occurs before date of general election)
- Live in your precinct at least 30 days immediately prior to an election
- Not be convicted and in jail
- Not claim the right to vote anywhere else.

Two forms of identification are required to register to vote:

- At least one of the two forms must show your name and current address
- Only one form of identification may be a piece of mail for a contractual service addressed and delivered to you

Vernon Township has voter registrars available to register voters Monday through Fridays between the hours of 8:30 a.m. to 4:30 p.m. Registration is open year round except during the 27 days preceding an election and reopens the second day following an election.

## **Highway Department Briefs**

#### **Snow Removal Procedures**

After a minimum 2" snowfall, parking is not permitted on Township maintained roads, until it has been cleared edge to edge. Parked vehicles may be towed with the owner responsible for related costs.


#### A Reminder When Shoveling Snow


When shoveling your driveway of snow, the best way to assure that the snow plows clearing the street will minimize the amount of snow left in an already cleared driveway is to shovel snow in the direction of traffic and also make a pocket on the opposite side of your driveway. (See illustration to the right.)


By doing this, snow that has accumulated on the plow will dump into that pocket, and will reduce the possibility of snowplows inadvertently making your driveway snowbound.

#### **Clearing Driveway Snow Sensibly**

When removing snow from your driveway, do not shove, push or blow it onto the public roadway, as this will create a slippery and hazardous surface when traffic passes over it. Also, don't push it to the other side of the road, as this would create a narrower area in the roadway at that point. Vehicles approaching from the opposite direction may find it difficult to pass safely through that area.







#### Don't Forget Your Mail Carrier

Clear an area in front of your mailbox so they can easily approach. If there is a fire hydrant on your property, shovel a path to and around it from the roadway.

### Vehicle Damage

To prevent damage to vehicles and snow plows please remove all decorative rocks, logs or other objects and place at least 6 feet from the paved edge of the road

### **Summer and Fall Projects**

The Wright Woods Tributary has been a source of flooding for South Elm Road and downstream to the crossing of River Oaks Drive. To alleviate the flooding, a new 36 inch diameter storm sewer was installed from the north end of South Elm Road approximately 800 feet to West River Oaks Drive, then approximately 400 feet west to connect with an existing storm sewer. Funding for this project was provided in part by the Lake County Stormwater Management Commission through a Watershed Management Board Grant.

In order to prevent erosion contamination from entering the Des Plaines River, the storm sewer project used a product called a Floc Log. The Floc Log is a tailored log block that contains a blend of water treatment components used to improve water clarification and control erosion. The Floc Log is hung in the storm sewer pipe. When erosion runoff comes into contact with the Floc Log, the chemicals react with the runoff. The fine particles bind together and become heavy, thus falling out of the water flow to the bottom of the pipe. The clean water then flows from the pipe into the waterway. The bound together particles move to the end of the pipe where a silt fence prevents the erosion contamination from entering the waterway. The Floc Log can be replaced during the project and removed when the project is complete.

Over the summer the highway department crew continued their efforts to keep storm water flowing unencumbered through the Vernon Township storm sewer system. Ditch work or storm sewer replacement occurred in several locations throughout unincorporated Vernon Township including Arlyd Road, Raleigh Drive, Raphael Ave, and two locations on Woodbine Circle

Additionally, all roads within the Krisview Subdivision along with Indian Creek Road, Hotz Road and Olsen Court were ground and repaved.

## The Assessor's Report

#### **Homestead Limited Exemption**

This exemption will lower the equalized assessed value of your property by \$6,000. This exemption is given to all properties automatically as long as it is your primary residence and you are not receiving a Homestead Exemption at any other property. Your primary residence is determined by your driver's license, voter registration and income tax return. There is no application or renewal to fill out for this exemption. Rental properties do NOT qualify for a Homestead Limited Exemption, and if you are receiving two, the county can recapture the money on your tax bill.

#### **Senior Citizens Homestead Exemption**

If you are the owner of a residential property and are 65 years or older, you qualify for a Senior Homestead Exemption. The Senior Homestead Exemption lowers your equalized assessed value \$5,000 in addition to the \$6,000 from your Homestead Limited Exemption. To figure out the exact amount you will get off your tax bill, you take the \$5,000 and multiple it by the tax rate for that year.

#### Senior Citizens Assessment Freeze

The Senior Freeze forms are mailed from the county between March and April. You will automatically receive an application if you are receiving a Senior Citizen Homestead Exemption. This second senior exemption does have a requirement of a household total income of \$55,000 or below including social security before deductions. If you do not receive an application the township assessor's office always has extras. The form does need to be notarized before mailing it back to the county. The Vernon Township's Assessor's Office will help you fill out this form, notarize it and mail it in for you.

#### Taxing Districts Levies Drive the Real Estate Tax Bill

Generally, taxes do not increase because of increasing assessments and they will not decrease when property values decline. On an individual basis, if assessments in one area of the township decrease and all others increase, the declining area may see some relief in their taxes, meaning the tax burden has been redistributed. However, if assessments all increase by a similar amount, say 10%, there will be absolutely no change in your tax bill UNLESS taxing districts levies change.

Levies increase because taxing bodies spending increases. Taxes increase when levies increase, even when assessments decrease. Assessments and tax rates do not create the tax burden and they do not change the tax burden; they only distribute the tax burden that is created by the levies of taxing bodies.

## Prairie View Train Station Overnight Parking

Overnight parking is available at the Prairie View Metra Station. Designated overnight parking spaces are number 117 through 124. ## Important: Please Read Before Camp Registration

- 1. Each camper requires his or her own registration form.
- 2. Do not mail in your camper's registration form.
- 3. **Proof of age (birth certificate) is required at registration**, for each new camper, including siblings of returning campers.
- 4. Proof of residency is required for ALL campers. (Drivers License or State I.D. only.)
- 5. All camps require a \$50 nonrefundable, nontransferable deposit at the time of registration, unless otherwise noted in the registration procedures. <u>Cash deposits will not be accepted.</u>
- 6. Camp registration will not proceed if items 3,4 and 5 listed above are not satisfied.
- 7. The fee balance is due on or before March 18, 2016. If the balance is not paid by that date, the camper's place will be given to a camper on the waiting list. No bill or reminder will be sent to you by Vernon Township. If you require a payment plan, you must contact the Township after January 7, 2016, but before January 29, 2016. You may pay the entire balance at the time of registration.
- 8. <u>After March 18, 2016, refunds will only be granted for medical reasons or if a replacement camper can be found by Vernon Township.</u> You must submit a letter from your doctor on his/her letterhead in order to receive this refund. Once camp begins, refunds will be prorated based on when participation will end.
- 9. Camp fees can not be prorated to accommodate vacations.
- 10. Vernon Township will reject any application or supporting information (proof of age, residency) determined to be fraudulent.
